



Rotary Club of Five Points New Member Proposal Package

General Qualifications — Rotarians are adults of good character and good business or professional reputation, who hold or have held an executive position with discretionary authority in any worthy and recognized business or profession. **Active Membership** — Active members must meet the above qualifications, as well as live or work within the club's locality or surrounding area.

Classification — Each active member of a Rotary club is classified in accordance with the member's business or profession. A classification describes the principal and recognized activity of the firm with which an active member is connected or the member's principal and recognized business or professional activity.

Proposal Procedure — The member of the club proposing the prospective member, the "proposer," completes the attached "New Member Proposal" form and provides it to the Membership Chair(s) or President, who then submit the New Member Proposal form, prospective member's name and proposed classification to the board of directors for review. The board ensures that the person is fully qualified and approves or disapproves the proposal. The proposer is notified of the decision by the club secretary. **NOTE:** Until approval is granted, prospective members should not be informed that they have been proposed for membership.

After approval by the board, the prospective member's name and classification is published in the Club Bulletin for two successive weeks. If no objections to the proposal are received following the second publication, the prospective member is fully informed of privileges, expectations and responsibilities of club membership in a scheduled "Rotary Talk." He or she is then asked to complete the "Proposed Member Information" form. Upon receipt of the completed form and induction fee, the person may be admitted to membership.
